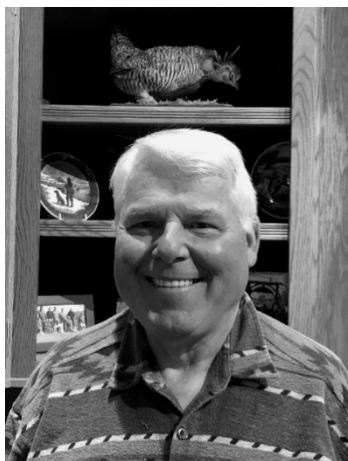

PRESIDENT'S MESSAGE



Welcome to the 70th running of our NGSPA Nationals and the fourth to be held at Grovespring, Missouri—the premier National Championship in the GSP world.

We continue to hear comments each year congratulating the NGSPA for moving our Nationals from Booneville, Arkansas. Our new grounds managed by the Field Trial Sportsmen Association have definitely “raised the bar” of performance required to win any of the stakes. With the added performance demands of our three Invitationals, the NGSPA is clearly focused on the improvement of the German Shorthaired Pointer breed.

END OF DUAL SANCTIONING PROGRAM

Last year, the NGSPA Board was faced with the challenge of dealing with the numerous issues that were raised by the AKC’s termination of our very successful “Dual Sanction” program. Our Affiliate Program with GSPCA clubs was also terminated. This left us without our major source of qualifying dogs to run in our Championships. We responded by changing our various entry qualifications. In effect, we expanded the list of qualifying events substantially. The new requirements are posted on our website, and they will also be discussed at our upcoming Delegates Meeting, so please plan to attend.

The end of our Affiliate Program also meant a reduction in revenue because over thirty member clubs were no longer paying their annual fifty-dollar membership fee. We discussed the idea of increasing our annual membership fees, but unanimously rejected this idea.

NGSPA WEBSITE

We launched our new website in January 2020, and it has continued to be improved by the hard work and dedication of Anthony Rusciano. Please be sure to view it often and to make use of the benefits it offers such as online National Championship entries. We continue to encourage each Championship club to update its historical pages as well as providing updated trial results. You will find a lot of useful information on our website.

NATIONALS COMMITTEE

Our Nationals Committee is dedicated to continually improving our Nationals, and they work really hard behind the scenes to put on this remarkable event. It takes a lot of work, and there are always challenges to overcome. At times, the job may seem thankless. 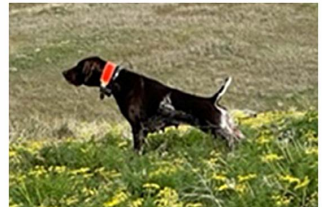

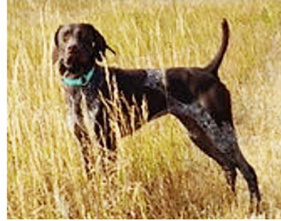

GSP FIELD TRIAL HALL OF FAME

Purpose:

To identify and honor those persons and dogs, past and present, whose accomplishments in field trial competition and contributions to the sport are exceptional. For dogs, outstanding performance and production records are required.

Criteria for Selection:

People:

1. The person must be at least 65 years old.
2. The person should have a significant record as a field trial competitor over a sustained period of time.
3. The person should have made a significant and sustained contribution to the sport by giving back through donation of time, resources, and expertise (for example, running trials, helping at trials, scribing, judging, providing grounds, encouraging, teaching newcomers, etc.).
4. This person must have exhibited exceptional sportsmanship, integrity, and a history of unselfish giving to the sport.

Dogs:

1. The dog must be deceased.
2. The dog should have a distinguished field trial record, especially in hour championships.
3. The dog should also have a record of producing outstanding progeny, both as competitors and producers.

Process of Selection:

Nomination and selection occur on an annual basis. The nominations open on January 1 and close August 31 annually. Any individual may nominate dogs and/or persons. It is the responsibility of the nominating person to provide all relevant data with regard to the nominee's accomplishments, which will support why that person or dog deserves to be considered for selection. **Nomination forms are available on the NGSPA website or from the Committee Chairman.** Completed forms and supporting documentation must be received by the chairman by the first of September each year. If a nominee is not selected to enter the Hall of Fame in the year nominated, the nominee will remain eligible for consideration for two (2) additional years. Thus, a nomination is valid for three (3) years at which time it will expire if the nominee has not been selected into the Hall of Fame. Nominations will

not be accepted for a nominee that fails to be selected in the first three-year period until a minimum of three (3) years after the expiration of the first nomination.

Selection Committee:

The Selection Committee is comprised of individuals who are selected for their experience, character, and integrity in German Shorthaired Pointer field trials and in breeding superior German Shorthaired Pointers. Their decisions on the merits of nominees are independent and kept anonymous. Each year's Honorees will be announced no later than the first of December annually. Inductees elected to the selection committee will serve a 3-year term and be eligible for one more consecutive 3-year term.

Induction:

Those selected will be formally inducted at ceremonies held at the Hall of Fame (Bird Dog Museum) in Grand Junction, Tennessee, on the Saturday before the beginning of the American Field Pointer National Championship in February.

Committee members & their dog(s) are ineligible for nomination to the Hall of Fame during their service on the committee.

Committee Structural Guidelines (These Reflect Past Precedents):

- While the GSP Hall of Fame Selection Committee serves at the pleasure of the NGSPA Board of Trustees, its decisions regarding inductees are to be totally independent of Board influence.
- Its operational procedures and membership are subject to Board of Trustee approval.
- The maximum size of the Committee is fifteen (15).

Chairman Responsibilities:

- The Chairman will be responsible to advise the Board of Committee member resignations and to present nominees to the Board for approval.
- The Chairman will serve as the GSP representative and present the inductees at the official induction ceremony.
- The Chairman will present proposed changes to procedures and processes to the Board of Trustees for approval.
- The Committee Chairman will provide a report at the annual Board of Trustees meeting.

2023 Field Trial Hall of Fame Inductees



Dean Crabbs

Dean Crabbs' commitment to the sport of field trialing and to the German Shorthaired Pointer breed has made him most deserving of induction into the German Shorthaired Pointer Field Trial Hall of Fame. Dean has been a tireless worker at field trials. He has been an

instrumental leader and worker for the GSP Club of Idaho helping to conduct AKC Field Trials, the NGSPA Region 9 Championship, and the AKC National Gun Dog Championship when it was held in Idaho. He successfully chaired the NGSPA National Championships for many years and continues to serve on the NGSPA Board of Trustees. The NGSPA National Championships grew each year under Dean's leadership.

In addition to being involved in GSP leadership positions, Dean has stepped up numerous times to judge countless AKC trials and NGSPA Championships, along with trials for other pointing dog breeds. Dean has also been known to volunteer his time judging AKC hunt tests and working at other GSP events.

Dean has owned several shorthairs that have earned both AKC and American Field trial wins and placements. Lonewolf's Huachuca Jake who was not only Dean's trusted chukar hunting companion, but was also a successful trial dog. Jake was an AKC Field Champion and AKC Amateur Field Champion. Dean also handled Jake to fourteen American Field placements of which better than half were championships.

As evident through his selfless dedication to the sport of field trialing and to the German Shorthaired Pointer breed, Dean exemplifies what it means to be a member of the GSP Field Trial Hall of Fame.

Keith and Robbi Gulledge of Blue Dawn Kennels located in Madison, Kansas, are arguably the most accomplished husband and wife team in field trial history. While Keith is known as an exceptional field trial handler, he points out

that Robbi has contributed to their success. She is not only an exceptional scout, but is also responsible for their successful breeding program and was the 2021 AKC GSP breeder of the year. Robbi is also the first female to place dogs in both the GSPCA National Open Gun Dog Championship and GSPCA National Championship.

The Gulledges not only attend field trials, but they help with them as well. They have used their strong relationships with landowners in Kansas to help secure grounds for area field trials. In addition, both have judged and assist with the GSPCA National Championship. They frequently scout for other professional handlers when asked.

Their win record is most impressive. The Gulledges have finished 96 AKC Field Champions, won the GSPCA National Championship ten times, the GSPCA National Gun Dog Championship eight times, and the GSPCA Futurity four times. They have won the NGSPA National Championship three times, the NGSPA Shooting Dog Championship nine times, and the NGSPA National Futurity four times. In addition, they have won the NGPDA National Championship three times and the NGPDA Shooting Dog Championship four times.

Although these wins alone more than justify their induction into the GSP Field Trial Hall of Fame, there is more to a Hall of Fame career than just winning field trials. The Gulledges have dedicated their lives to improving, participating, and promoting all aspects of field trials and the German Shorthaired Pointer breed.



Kyle's Hightailing Luke

Kyle's Hightailing Luke, a German Shorthaired Pointer male, was whelped on February 13, 2001, in a litter bred by Stephanie Devine. He was sired by Hall of Fame KJ's Hightailing Saddle and bred to Stephanie's all-age bitch

Devine's Tasmanian She Devil, which was a daughter of Heide's Mighty City Slicker and Chicoree's Cherry Cola.

Hank Lewis acquired Luke at a young age. Luke showed early promise and capped off his derby career by winning the 2022 NGSPA Pheasant Derby Classic. Robert Reynolds, DVM, purchased Luke in the Spring of 2003. Luke finished his AKC Field Championship in September 2003 in Michigan by winning the Open Limited Gun Dog stake against an impressive field.

Luke, who had a host of field trial wins, was the first dog to win the NGSPA Pheasant Open All-Age Championship three times, only to be equaled by his son Kane. An unfortunate kennel accident claimed Luke's life when he was reaching the height of his competitive career at six years of age.

Even with limited production due to his early death, Luke produced eleven AKC Field Champions, seven AKC Amateur Field Champions, and three GSPCA Futurity placements. In American Field competition, he produced twelve winners with 152 placements. These include nine championships, including an NGSPA National Champion and two NGPDA Open All-Age Championships. Luke's ability to pass on his natural abilities through his get is evidenced by his grandson—Hi-N's Feed Jake—the 2015 NGSPA National Champion.

Luke has truly had a positive genetic impact upon the breed and deserves his induction into the GSP Field Trial Hall of Fame.

Franklin, Tennessee

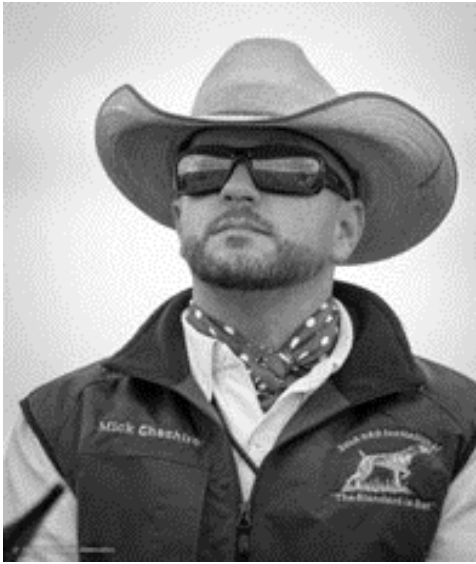
National Championship

Highlands Ranch, Colorado

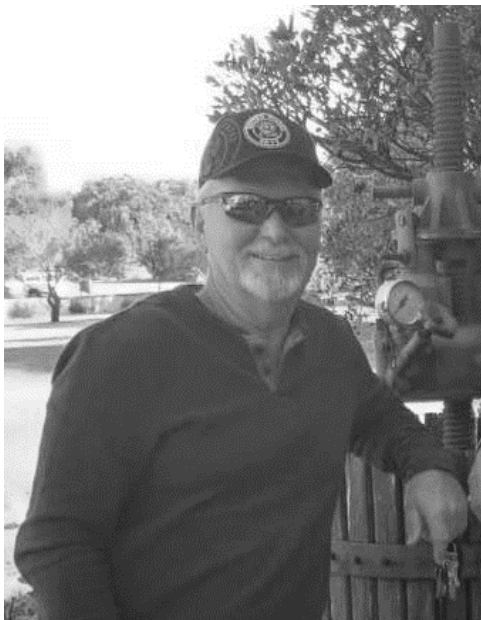
