**NGSPA SHARPTAIL CHAMPIONSHIP
ANNOUNCEMENT OF CHANGES AND REQUEST FOR PROPOSAL**

The NGSPA Board of Trustees received a complaint against the leadership of the Sharptail Championship requesting that the NGSPA remove sanctioning from the NGSPA Sharptail Association for a number of specified reasons. A hearing regarding this matter was held on April 4, 2023 in Grovespring, MO.

After considering all of the written testimony and evidence the Board of Trustees unanimously approved the following motion:

It has been sufficiently proven that the board should remove the sanctioning of the NGSPA Sharptail Association as it is currently organized under the Chairmanship of Tom Davis, and if the Sharptail Championship is reorganized in the future, Tom Davis will not be allowed to be a part of the leadership team.

As a result the sanctioning for the NGSPA Sharptail Association as it has been organized has been removed.

The Board of Trustees wants to see the NGSPA Sharptail Championship reorganized under leadership capable of holding a wild bird Championship meeting the standards of excellence required by the NGSPA.

We will hear proposals from interested and qualified parties at our June, 2, 3 meeting.

An estimated crowd of four hundred people gathered at Grand Junction, Tennessee, on Saturday, February 11th, 2023, to honor the induction of individuals and several breeds of bird dogs into the National Bird Dog Hal of Fame.

The morning started with the English Springer Spaniel Field Trial Association inducting Mike Elsasser, a professional spring trainer and handler, along with Spring Spanies, Cathy's Kris of Burnsget and Flushing Wing Annie into their Hall of Fame. This was followed by the Retrievers inducting Laura Parrott and the late Jack Vollstedt along with Labrador Retrievers Bayou Star Beyond Independent and Lock Five's Got Her Blue Genes On into the Retriever Hall of Fame.

Nestle Purina sponsored an excellent luncheon which featured two different salads, roasted pork and chicken, baked potatoes with bacon bits, butter beans, rolls and two different desserts. A total of 340 individuals were served lunch in connection with the Hall of Fame activities. Ainley Kennels and Fabrication, Avery Sporting Dog, Garmin, and Gundog Central also co-sponsored the events of the day.

There were a number of Shorthair enthusiasts in attendance who spent time in the improving Shorthair exhibit of the museum. Mike Aldrich and Gene Mosley deserve your accolades for their work, time, and effort on the Shorthair exhibit.

Tonya Brotherton, Executive Director of the Bird Dog Foundation, Mark Medford, President of the Bird Dog Foundation, and Karl Gunzer of Nestle' Purina made opening remarks to start the afternoon session of the Hall of Fame ceremonies.

This afternoon session followed with the presentation of a plaque by Bonnie Hidalgo honoring the late Ray Dohse of Wrightsville, Georgia, a professional bird dog trainer who enjoyed success with German Shorthairs and Irish Setters. This was followed by Don Kidd presenting a

plaque honoring Jim Yates of Picknville, Michigan, an outstanding German Shorthair field trailer, to the Bird Dog Museum.

The following program honored the distinguished individuals and the owner of an outstanding dog who were elected to the German Shorthaired pointer Field Trial Hall of Fame in 2022.

DEAN CRABBS

Dean Crabbs' commitment to the sport of field trialing and to the German Shorthaired Pointer has made him most deserving of induction into the German Shorthaired Pointer Hall of Fame.

Dean has been a tireless worker at field trials. He has been an instrumental leader and worker for the GSPC of Idaho helping to conduct AKC field trials, the NGSPA Region 9 Championship, and the AKC Gun Dog Championship when it was held in Idaho. He successfully chaired the NGSPA National Championship for several years, and this championship grew each year under his leadership.

Dean served not only as the President of the GSPC of Idaho but, also, was a member of the board of the NGSPA for several years. In addition to being involved in GSP leadership positions, he has stepped up numerous times to judge countless AKC trials, several NGSPA Championships, along with trials for other pointing dog breeds. Dean has also been known to volunteer his time judging AKC hunt test and working at other GSP events.

Dean has owned several Shorthairs who have earned both AKC and American Field trial wins and placements. Lonewolf's Huachuca Jake, who was not only Dean's trusted chukar hunting companion, but was also, a successful trial dog. While Jake was an AKC Field Champion and a AKC Amateur Field Champion, Dean handled Jake to fourteen American Field Trial placements of which better than half were Championships.

As evident through his selfless dedication to the sport of field trialing and, to the German Shorthaired breed, dean exemplifies what it means to be a member of the GSP Field Trial Hall of Fame.

KEITH & ROBBI GULLEDGE

Keith & Robbi Gullledge of Blue Dawn Kennels, located in Madison, KS, are arguably the most accomplished husband and wife team in field trial history. While Keith is known as an exceptional field trial handler, he points out how Robbi has contributed to their success. She is, not only, known as an exceptional scout, but is also responsible for their successful breeding program and was the AKC 2021 GSPCA Breeder of the Year. She is also the first female to place dogs in both the GSPCA National Open Gun Dog and the GSPCA National All Age Championship.

The Gulledges not only attend field trials but they help with ten, as well. They have used their strong relationships with landowners in the area to help secure grounds for area field trials. In addition to both of them having been in the judicial saddle on several occasions, they assist with the GSPCA National Championship which is held nearby in Eureka, KS. They frequently scout for other professional handlers when asked.

Their win record is most impressive. The Gulledges have finished 96 AKC Field Champions, won the GSPCA All Age Championship ten times, the GSPCA National Gun Dog Championship eight times, and the GSPCA Futurity four times. They have won the NGSPA National All-Age Championship three times, the NGSPA Shooting Dog Championship nine times, and the NGSPA Futurity four times. In addition, they have won the National German Pointing Dog Association All-Age Championship three times and the Open Shooting Dog Championship four times.

These wins alone are more than enough to deserve their distinct honor of joining the current members of the German Shorthaired Pointer Field Trial Hall of Fame. There is more to a Hall of Fame than just winning field trials. The Gulledges have dedicated their lives to improving, participating and promoting all aspects of field trials and the German Shorthaired Pointer breed.

KYLE'S HIGHTAILING LUKE

Kyle's Hightailing Luke, a German. Shorthaired Pointer male, was whelped on February 13, 2001, in a litter bred by Stephanie Devine. He was sired by Hall of Fame KJ's Hightailing Saddle and bred to Stephanie's All-Age bitch Devine's Tasmanian She Devil, who was a daughter of Heide's Mighty City Slicker and Chicoree's Cherry Cola.

Luke was acquired at an early age by Hank Lewis. Luke showed early promise and capped off his derby career by winning the 2002 NGSPA Pheasant Derby Classic.

Robert Reynolds, DVM, purchased Luke in the Spring of 2003. Luke finished his AKC Field Championship in September 2003 at the Michigan field trial by winning the Open Limited Gun Dog stake against an impressive field.

Luke, who had a host of field trial wins, was the first dog to win the NGSPA All-Age Pheasant Championship three times only to be equaled by his son, Kane, as a three time winner. An unfortunate kennel accident claimed Luke's life when he was reaching the height of his competitive career at 6 years of age.

Even with limited production due to his early death, Luke produced eleven AKC Field Trial Champions, seven Amateur Field Trial Champions, and three GSPCA Futurity placements. In American Field competition, he produced twelve winners with 152 placements.

These include nine championships including a NGSPA All-Age Champion and two National German Pointing Dog Association All-Age Championships. Luke's ability to pass on his Natural abilities through his get is evidenced by his grandson, Hi-N's Feed Jake, the 2015 National Al-Age Champion.

Luke has truly had a positive genetic impact upon the breed and deserves recognition in the German Shorthaired Pointer Field Trial Hall of Fame.

William F Fred Rail, Jr. a professional bird dog trainer and David Johnson were elected into the Pointer/Setter Field Trial Hall of Fame. Fred Ray

handled twenty-eight champions of which three - Builder's Addition, Fiddler and Fidler's Pride, were elected to the Hall of Fame. David Johnson, over his career scouted 130 champion pointers to their wins. He is considered a living tribute to the "Golden Age of Scouting".

Miller's Happy Jake, owned by Scott Griffin of Mint Hall of North Carolina and handled by Randy Anderson of Vinita, Oklahoma, and Just Irresistible, owned by Mary Devon, and handled by Jamie Daniels were the Pointer/Setter dogs inducted into the Hall of Fame.

The American Brittany Club (ABC) selected Mary E Crawford for induction into the Field Trial Hall of Fame. Mary, who is well known to many Shorthair field trailers, served as Field Trial Secretary for the ABC national All Age Championship for several years, was a member of the National Show Committee in the 1990's and currently serves on the Judges Education Committee.

Mary and her Husband, Jim, have produced 14 dual/amateur field champions, 3 field/amateur field champions.

Mary is a Bird Dog Foundation member, serving as secretary, and a donor to the Brittany Endowment Fund. She personally researched and save photographs of Hall of Fame dogs and people. She personally framed 57 photographs to complete the ABC exhibit of Hall of Famers. The afternoon continued with the National Red Setter Field Trial Club announcing that their 2022 Hall of Fame Inductee was Roger Boser of Seven Valleys, Pennsylvania, who joined the Red Setter club at age 16 and maintained that membership for 64 years. He held nearly every position in the Red Setter Field Trial Club and successfully field trialed Red Setters to 87 championships and 82 runner-up placements.

Zan Sett Simply Red, bred by Stan Zdzanczewicz, owned by Catherine Lewis and Dean Reinke and handled by Tom Waite was the 2022 Red Setter to be inducted.

A reception honoring all of the day's hall of Fame inductees sponsored by the United Kennel Club followed the foregoing presentations.

RULES FOR CHAMPIONSHIP QUALIFICATIONS

Revised June 1, 2022

ELIGIBLE DOGS

Running Rules Chapter 2, Article II, Section 6. Eligible Dogs.

All dogs entered in any NGSPA Championship must be registered as a German Shorthaired Pointer in the American Field Dog Stud Book ("FDSB"). All dogs must comply with American Field Dog Stud Book DNA testing requirements. (See NOTE below)

CHAMPIONSHIP QUALIFICATIONS

These Qualifications are for dogs entering any NGSPA recognized Championships, Regional or Species. They do not apply to the Nationals or Invitational.

Section 6. Qualifications.

Any eligible dog may be entered in any NGSPA Championship or Derby Classic.

NOTE: The *Field Dog Stud Book* requires all pointing dogs that win championship placements (winner and runner-up), open and amateur, to submit DNA to the FDSB for testing within 30 days of the win. Failure to comply with this requirement shall result in those dogs' records being suspended until this requirement is met.

NATIONAL CHAMPIONSHIP QUALIFICATIONS

Running Rules Chapter 2, Article III Section 2. Qualifications for the National Championship, National Amateur Championship, National Open Shooting Dog Championship, National Amateur Shooting Dog Championship, and any other National Championship stakes.

(A) Qualification for Life. The following qualify a dog for life, for entry in the National Championship (All Age), National Amateur Championship (All Age), National Open Shooting Dog Championship, National Amateur Shooting Dog Championship, and any other National Championship(s) (excluding the Futurity) the Board determines to hold:

- (a) A win (Champion or RU Champion) in an NGSPA or American Field Championship of an hour in length or more.
- (2) A win (1st, 2nd, or 3rd) in a broke dog stake in any NGSPA, American Field or AKC sanctioned pointing dog field trial.

FIELD TRIAL HALL OF FAME

GUIDELINES AND PROCEDURES

PURPOSE:

To identify and honor those persons and dogs, both past and present, whose accomplishments in Field Trial Competition are exceptional, and whose contributions to the sport are outstanding.

CRITERIA FOR SELECTION:

PEOPLE

1. The person must be at least 65 years old.
2. The person should have a significant record as a Field Trial competitor over a sustained period of time.
3. The person should have made a significant and sustained contribution to the sport by “giving back” through donation of time, resources and expertise, (for example: running trials, helping at trials, scribing, judging, providing grounds, encouraging and teaching newcomers, etc., etc.).
4. The person must have exhibited exceptional sportsmanship, integrity, and a history of unselfish giving to the sport.

DOGS

1. The dog must be deceased.
2. The dog must have a distinguished Field Trial record, especially in one hour Championships.
3. The dog must have a record of producing outstanding progeny, both as a competitors and as producers.

PROCESS OF SELECTION:

Nomination and selection occurs on an annual basis. The nominations open January 1 and close August 31 annually. Any individual may nominate dogs and/or persons. It is the responsibility of the nominating person to all relevant data with regard to the nominees' accomplishments, which will support why that person or dog deserves to be considered for this award.

Nomination forms are available on the NGSPA website (www.ngspa.org) or from the Committee Chairman. Completed forms and supporting documentation must be received by the Chairman by the first of September (September 1) each year. If a nominee is not selected to enter “The Hall” in the year nominated, the nominee will remain eligible for consideration for two (2) additional years. Thus, a nomination is valid for three (3) years, at which time, it will expire if the nominee has not been selected into the Hall of Fame. Nominations will not be accepted for a nominee that fails to be selected in the first three year period until a minimum of three (3) years after the expiration of the first nomination.

SELECTION COMMITTEE:

The Selection Committee is comprised of individuals who are selected for their experience, character and integrity in German Shorthaired Pointer field trials, and in breeding superior German Shorthaired Pointers. Their decision on the merits of nominees are independent and kept anonymous. Each year's Honorees will be announced no later than the first of December annually. Individuals elected to the selection committee will serve a 3 year term, and be eligible for one more consecutive second 3 year term.

INTRODUCTION:

Those selected will be formally inducted at ceremonies held at the Hall of Fame (Bird Dog Museum) in Grand Junction, Tennessee, on the Saturday before the beginning of the Pointer National Championship.

Committee members & their dog(s) are ineligible for nomination to the Hall of Fame during their service on the committee.

HALL OF FAME COMMITTEE STRUCTURAL GUIDELINES (These reflect past precedents)

- While the GSP Hall of Fame Selection Committee serves at the pleasure of the NGSPA Board of Trustees, its decisions regarding inductees are to be totally independent of the board influence.
- Its operational procedures and membership are subject to the BOT approval.
- The maximum size of the committee is 15.

CHAIRMAN RESPONSIBILITIES

- The Chairman will be responsible to advise the Board of Committee resignations, and to present nominees to the Board for Approval.
- The Chairman will serve as the GSOP representative and present the inductees at the official induction ceremony.
- The Chairman will present proposed changes to procedures and processes to the BOT for approval.
- The Committee Chairman will provide a report at the annual BOT meeting.

FIELD TRIAL HALL OF FAME

2023 NOMINATION FORM

Please note all nominations must be received no later than August 31 of the nomination year.
(Nominations are good for three years).

In order to be nominated, dogs must be deceased. Persons may be nominated, living or dead; however, they must be at least 65 years of age, if still living.

FOR DOGS

In order to be considered, a resume that depicts a candidates complete field trial record in all types of field trial events, the candidate's progeny and their quality. The dogs candidacy should be dependent on his entire competitive career, and the quality of his/her offspring.

FOR PERSONS

Persons to be nominated and selected into the GSP Field Trial Hall of Fame, need to have rendered outstanding service to the sport of field trialing, both at a local and national level for a long period of time. They need to have significant contributions that have made a measurable difference in the improvement to the sport of Field Trialing. Activities such as judging, being a club official, breeder, handler and/or a sustained record of breeding German Shorthaired Pointers which have contributed to the improvement of the GSP as a breed.

Because this is a great honor to bestow upon a person, the Election Committee needs an accurate and complete biography. Incorrect or misleading facts within the biography will cause the nomination to be denied until it is updated and corrected.
