

The course that we ran was an out and back, starting at the Boy Scout camp area and only using the left hand side of the island. There was plenty of excitement watching the 17 derby dogs run and handle the open grounds, some encountering their first ever pheasant find.

First place went to Monica's Quail Point Sheba owned by Mick Monica and handled by Mike Mullineaux. Sheba had some nice casts and ran a forward race.

The judges stated Sheba demonstrated that she has the potential to be a nice running, forward moving dog as she matures.

Second place went to RN's High Riden Lizie owned by Ray Nelson and handled by Dan DiMambro. Lizie ran a strong forward race. As a young dog she made some immature moves but she handled kindly and required little scouting by April DiMambro. Third place went to Toots Toots Tootsie owned and handled by Wayne Horner. This young dog had a solid shooting dog range while jumping in and out of cover. She demonstrated excellent potential and this snappy little dog caught the judges attention.

This large stake had 40 dogs and was run over 3.5 days.

Robbi is owned by Sherri Tangsrud and handled by Kirk Loftin. Robbi was all business as she rimmed the edges in search of game. Robbi was rewarded with three finds all pointed with style. 2023 NGSPA REGION 3 CHAMPIONSHIP

The NGSPA Region III Championship started on Saturday, November 11, 2023, after the conclusion of the NGSPA Pheasant Championship Open Shooting Dog Stake. The championship was run on the scenic grounds of Wye Island, Maryland. Region III is a fun, but challenging championship because although we transition to quail there are still 300+ pheasant running around the island grounds. With an abundance of pheasant still on the grounds from the prior championship and over 300 quail utilized throughout the event the dogs had plenty of opportunities to point game.

Although the NGSPA Pheasant Championship is a tough act to follow and many participants need to leave to return to work obligations, it is necessary for us to make the sacrifice and run this championship because of the lack of NGSPA events we have available on the east coast. Pulling off two NGSPA back to back events with a very small handful of volunteers is draining, but the reward is to see that the attendees are thankful for the efforts. Region 3 is grateful for those that were able to stay and support the event.

To our sponsor Purina Pro Plan and Greg Blair we would like to express our sincere gratitude and huge "Thank You" for your years of sponsorship, it is greatly appreciated. Although this year was our largest turn out of participation unfortunate incidents happen and this year was not without our own challenges. Two judges dropped out last minute and we were unable to replace them so we had to cancel the ASD stake. All of the amateur participants were actually relieved because many of the same dogs, handlers and horses participated throughout both events and they did not want to overdo it and wanted to avoid injuries.

Region 3 Open All Age

A total of 26 dogs competed in the All Age stake that started on Saturday afternoon November 11, 2023. Our judges were Bo Manounis from New Jersey and Cory Roy from Connecticut. Both gentlemen have spent time in the saddle judging and handling pointing dogs. Bo is an English Pointer owner/handler and Cory is a GSP/Vizsla owner/handler, both judges actively campaign their dogs in American Field events.

"Woody" - HighStanding Cuttin Edge owned by Anthony & Dayna Rusciano ran mid-morning on day two in brace (7B). Handler Dan DiMambro broke Woody away as he stretched out strong, forward and to the front. Woody disappeared and was found standing at 12.

Quail were produced as they flew directly over his head he stood with style. Woody was sent on and was found standing at 17 in the far back reaching corner of the large back field on the property past the gates. A pheasant was produced. Woody was once again rewarded with a find at 40, with style and manners. Woody made a huge finishing cast to time around the entire edge of the tree line of the large Boy Scout field. Woody was an all around powerful dog for the hour, he handled kindly earning him 2023 Region 3 All Age Champion.

Runner Up Champion Chicorees Riden High Trixie was in brace (6B) on the second day. Trixie is owned by Rondal Alexander and handled by Dan DiMambro. Trixie is a true all age competitor and has done plenty of winning throughout the years. Trixie started off the hour with a strong forward cast down the tree line as far as the eye could see. She ran a strong all age race around the island in search of game. She was found to the front standing on all of her finds. Trixie had three evenly spaced finds two small quail coveys and a Pheasant. She stood her birds with great style and manners and was able to pin down a moving Pheasant. Trixie's ground speed and style complemented this years Champion.

The judges complemented that there was some really great competition and they appreciated watching these strong running dogs navigate the grounds. They said that all dogs pointed game unless the handler called for the tracker due to a lost dog. The judges noted that they were splitting hairs with a few of the dogs but that the Champion and Runner Up had no flaws and stood out amongst the others for this stake. GUIDELINES AND PROCEDURES

PURPOSE:

To iden(fy and honor those persons and dogs, both past and present, whose accomplishments in Field Trial Compe((on are excep(onal, and whose contribu(ons to the sport are outstanding.

CRITERIA FOR SELECTION:

PEOPLE

1. The person must be at least 65 years old.

2. The person should have a significant record as a Field Trial compe(tor over a sustained period of (me. 3. The person should have made a significant and sustained contribu(on to the sport by "giving back" through dona(on of (me, resources and exper(se, (for example: running trials, helping at trials, scribing, judging, providing grounds, encouraging and teaching newcomers, etc., etc.).

4. The person must have exhibited excep(onal sportsmanship, integrity, and a history of unselfish giving to the sport.

DOGS

1. The dog must be deceased.

2. The dog must have a dis(nguished Field Trial record, especially in one hour Championships.

3. The dog must have a record of producing outstanding progeny, both as a compe(tors and as producers.

PROCESS OF SELECTION:

Nomina(on and selec(on occurs on an annual basis. The nomina(ons open January 1 and close August 31 annually. Any individual may nominate dogs and/or persons. It is the responsibility of the nomina(ng person to all relevant data with regard to the nominees' accomplishments, which will support why that person or dog deserves to be considered for this award.

Nomina(on forms are available on the NGSPA website (www.ngspa.org) or from the CommiUee Chairman. Completed forms and suppor(ng documenta(on must be received by the Chairman by the first of September (September 1) each year. If a nominee is not selected to enter "The Hall" in the year nominated, the nominee will remain eligible for considera(on for two (2) addi(onal years. Thus, a nomina(on is valid for three (3) years, at which (me, it will expire if the nominee has not been selected into the Hall of Fame. Nomina(ons will not be accepted for a nominee that fails to be selected in the first three year period un(I a minimum of three (3) years aWer the expira(on of the first nomina(on.

SELECTION COMMITTEE:

The Selec(on CommiUee is comprised of individuals who are selected for their experience, character and integrity in German Shorthaired Pointer field trials, and in breeding superior German Shorthaired Pointers. Their decision on the merits of nominees are independent and kept anonymous. Each year's Honorees will be announced no later than the first of December annually. Individuals elected to the selec(on commiUee will serve a 3 year term, and be eligible for one more consecu(ve second 3 year term.

INTRODUCTION:

Those selected will be formally inducted at ceremonies held at the Hall of Fame (Bird Dog Museum) in Grand Junc(on, Tennessee, on the Saturday before the beginning of the Pointer Na(onal Championship. CommiUee members & their dog(s) are ineligible for nomina(on to the Hall of Fame during their service on the commiUee.

HALL OF FAME COMMITTEE STRUCTURAL GUIDELINES (These reflect past precedents)

•While the GSP Hall of Fame Selec(on CommiUee services at the pleasure of the NGSPA Board of Trustees, its decisions regarding inductees are to be totally independent of the board influence.

- •It's opera(onal procedures and membership are subject to theBOT approval.
- •The maximum size of the commiUee is 15.

CHAIRMAN RESPONSIBILITIES

•The Chairman will be responsible to advise the Board of CommiUee resigna(ons, and to present nominees to the Board for Approval.

•The Chairman will serve as the GSOP representa(ve and present the inductees at the official induc(on ceremony.

•The Chairman will present proposed changes to procedures and processes to the BOT for approval.

•The CommiUee Chairman will provide a report at the annual BOT mee(ng.

FIELD TRIAL HALL OF FAME 2024 NOMINATION FORM

In order to be nominated, dogs must be deceased. Persons may be nominated, living or dead; however, they must be at lease 65 years of age, if s(II living.

FOR DOGS

In order to be considered, a resume that depicts a candidates complete field trial record in all types of field trial events, the candidate's progeny and their quality. The dogs candidacy should be dependent on his en(re compe((ve career, and the quality of his/her offspring.

FOR PERSONS

Persons to be nominated and selected into the GSP Field Trial Hall of Fame, need to have rendered outstanding service to the sport of field trialing, both at a local and na(onal level for a long period of (me. They need to have significant contribu(ons that have made a measurable difference in the improvement to the sport of Field Trialing. Ac(vi(es such as judging, being a club official, breeder, handler and/or a sustained record of breeding German Shorthaired Pointers which have contributed to the improvement of the GSP as a breed.
